## MEMBERSHIP AGREEMENT AND POLICIES

*This agreement must be signed prior to audition – no exceptions.*

### If selected, and if I agree to join Anchorage Concert Chorus (ACC), I will:

1. Abide by ACC Bylaws and Membership Policies and Procedures as set by the Board of Directors.
2. Re-audition each year if required and surrender my place, should I choose not to return, and understand that a new member will be selected to fill my place.
3. Pay \$175 annual dues in full by the first rehearsal in October. I understand music for the first concert will not be issued until dues are paid in full, unless an exception has been granted me by the Board of Directors.\* (Post-dated checks are not accepted. Refunds are not issued after the sixth rehearsal.)
4. Pay replacement costs for all music not returned to the Music Librarian, or not returned in a condition that makes the music unusable.
5. Raise a minimum \$250.00 for ACC by either: (1) selling raffle tickets (2) soliciting Sponsor-A-Singer pledges (3) soliciting a cash donation (4) making a personal donation. I understand that failure to meet this obligation by January 1 may result in forfeiture of singing privileges for the season.
6. Be on time to rehearsals, which is defined as: in place and ready to sing when warm-ups begin.
7. Inform my section leader should I arrive late, leave early or expect to be absent. A half-absence will be assessed if I am late or leave rehearsal early. Be responsible for obtaining information, markings and instructions given on my voice part during my absence from my section leader or a fellow singer.
8. Inform my section leader if I am dropping out for a concert or for the remainder of the season.
9. Re-audition should I accumulate three absences during a concert period. I understand I will be required to demonstrate musical proficiency to the conductor or designee. If unsuccessful, I may not be permitted to sing in the corresponding performance for that time period and/or possibly face termination of my membership.
10. Not participate in performance(s) for which I have missed a dress rehearsal, unless I have received permission to do so from the conductor.
11. Adhere to the ACC concert dress code policy as listed in Membership Guidelines.
12. Be responsible for reading the ACC Membership Guidelines available on website or upon request.
13. Perform all Chorus music and be present at all Chorus performances during the season.

***I agree to these terms as condition of membership in Anchorage Concert Chorus as stated above, certify that I am at least sixteen years of age as of this date, and attest to the same by signing this agreement.***
